PAWS Update: Natalie Newell

- PAWS membership drive—which, for the first time, was conducted online—has been very successful. Membership has reached 274 families and 100% of teachers and staff. Tiffany Carson coordinated a positive message initiative to inform teachers and families of the benefits PAWS membership has for students.
- PAWS had its first Board meeting on August 2, 2018.
- PAWS will be working with Lauren Manfreda on Fun Fest to prepare an activity booth and help man the hot dog stand.
- The PAWS Mane Event is Wednesday, August 15, 2018. The theme this year is "Learn by Doing," and PAWS will showcase each of its committees, describe its mission, and explain how it helps the School and organization.

• Finance Committee

- o This year, the School will receive a small increase in the per pupil revenue it receives from the State.
- Israa Kanfoud has begun working on strategic planning for the School's finances.
 He is preparing a tool that will allow quick manipulation of data and assumptions.
 The Finance Committee will use this tool to track opportunities and risks and make better informed financial decisions.
- Consistent with the School's efforts to keep Athletics under its umbrella, Boosters has closed its bank account. All of its former funds have been deposited into School's account and earmarked for athletics.

• Governance Committee

Tracy DeMarco

- o 2018-2019 Goals:
 - Revise Admissions Policy.
 - The Committee is considering revisions to the day 1-20 attendance and waitlist notification/acceptance procedure. The current policy creates a potential 48+ hour window where there may be no student filling an available seat. Because the School's State funding is based solely upon attendance in the first 20 days, the Committee is discussing potential ways to minimize absences caused by seat vacancies and unexcused absences during that time period.
 - Continue process for drafting Field Trip Safety recommendations.
 - Kim Keith began this initiative at the end of the 2017-2018 school year, bringing together teachers and parents for an open discussion to address a number of issues surrounding field trips. This discussion will continue in the 2018-2019 school year with the goal of preparing a set of safety guidelines applicable to all field trips.
 - Finalize review of all School policies.
 - Research and establish process for Board assessment and development.

o 2018-2019 Goals:

- The Community Engagement Committee is responsible for fostering a relationship with the community and other stakeholders. In addition, Nick Cerullo will attend all Development Committee meetings.

Update to Beginning Teacher Support Program:

• State has issued a new list of requirements for the Beginning Teacher Support Program. Christi has been working on revisions to the ECS program and anticipates being ready to share a draft with the Board before next meeting.

Director's Update: Christi Whiteside

- Current enrollment is 511. We are still trying to fill 2 8th grade seats. Governance
 Committee will be looking at our Admissions Policy to see if ECS can speed up the
 admissions process.
- ECS has held 3 parent events so far Meet the Teacher and 2 Curriculum Nights. All were well received.
- Volleyball is an official ECS sport. Mark Root is coaching, and 22 girls are on the team.

- 78 students are participating in fall sports.
- 6th graders were invited to join cross country and boys soccer.
- ECS hosted Wake Forest Police Department during the teacher workdays. They provided an active shooter training and will return for our next lock down drill to provide additional suggestions.
- ECS is partnering with the Fill Your Bucket List Foundation for a school wide service project. More info to come!
- Bill Kroll recommended the November 19 date for the Nov Board meeting. Please adjust your calendars!
- Carpool is starting to smooth out. We have more kindergarten students than usual who need help opening doors and getting in or out. For anyone who has such special needs or is unable to independently handle carpool, it was recommended to come close to 8:15 in the morning and 3:40 in the afternoon. Those times have less traffic. Three letters have been sent to parents who were disrespectful to carpool staff.
- Math 1 classes are larger than is typical this year. For this year, Mrs. Southard is in class and supporting Mrs. Tyler as she seeks materials, etc. Mrs. Southard will also be available to provide extra support for any student who struggles during the school year.
 - Some statistics: Last year One 7th grade math class had 22 students, Math 8 had
 21, Math 1 had 17 per class
 - O This year One 6th grade class has 21, 7th grade has 19, Math 8 has 10, Math 1 has 24 or 26 (we lost 4 students who had enrolled in Math 8 and were replaced by students in Math 1)
- Changed landscaper. New company has mulched, fixed a number of landscaping issues, saved our fence. Will talk to him about Spring issues later in the semester.
- We will delay looking at the new requirements for Beginning Teachers until September.
- PAWS considering coupon books. Families or kids selling things have always been something ECS has tried to avoid. Struggle with messaging with Annual Fund and what is needed to fund the bottom line.
