- The PAWS Halloween breakfast for teachers was a success, and PAWS is now planning the teacher holiday luncheon.
- Teacher appreciation week is scheduled for February 11-13, 2019. PAWS is working on a theme relating to love. This year, the goal is to keep things simple and have families send in items for teacher appreciation once or twice during the week.
- The ECS Art show is scheduled to take place February 27-28, 2019. Each participating child will have one piece of artwork framed, and parents can choose to purchase the framed work for \$20. There is no charge for participation; instead the coordinating company take a percentage of each sale and PAWS receives the remainder as a fundraiser for the School.
- Terracycle took place on November 1st. The collection totaled 256 lbs and was the largest PAWS has ever collected. The next teracycle will take place on December 6th.

- Leadership team is looking at the format of our pep rallies and ways to capitalize on our professional development time.
- Boys and Girls Basketball is underway.
- Day of National Parks was last Friday. It was a big hit with kids and teachers alike. We hosted park ranger speakers, activities focused on specific parks or park features such as geysers. We will be getting more formal feedback from staff to determine whether the theme day will be our new permanent direction for the Day of...
- The changes to our admissions policy discussed at the last Board meeting have been approved by our school law attorney and the Governance Committee. The new updated policy is below. It needs Board approval.
- We are running into a few situations where difficult divorces are creating challenges for our teachers. To address the problems we're having and to handle them equitably, we are planning to add these guidelines to the family and staff handbooks next year:

Legal custody arrangements will always be followed. In the case where no such paperwork is provided or such paperwork does not provide guidance, the following guidelines will be followed:

- 1. We will not hold separate conferences for the parents of a single child. Parents can both attend the same conference in person, both via skype or conference call, or one of each. If both parents cannot agree on who may appear live at a conference, then both parents must appear via skype or conference call. Holding separate conferences would certainly result in parents hearing different information based on questions asked, etc. If either parent feels unsafe, we will arrange for a police officer to be present for the conference.
- 2. Any communication going to either parent from the classroom, including a response to an email from one parent, will be sent to both parents.
- 3. Conversations with school staff should always focus on the child and not on the other parent. Staff will not engage in such conversations.
- 4. It shall be the intent that both parents receive equal access to communication from the school. No additional parties will be granted such communication unless agreed upon in writing by both parents.
- 5. Emergency pick-up contacts, other. the parents, must be agreed upon in writing by both parents.
