Approval of Counsel for Bond Audit:

 Tracy DeMarco explained that the North Carolina Capital Facilities Finance Agency, Educational Facilities Revenue Refunding Bond, which Endeavor received in 2016, has been randomly selected by the IRS for an audit. Jeff Poley of the law firm Parker Poe Adams & Bernstein LLP ("Parker Poe") represented ECS in the original bond proceedings and, therefore, appears best suited to handle the audit. The formal engagement will be between Parker Poe and the North Carolina Capital Facilities Finance Agency because the audit request is addressed to the Agency and the Agency, not Endeavor, must respond. Endeavor must also sign the engagement letter because, pursuant to the terms of the Bond, it must indemnify the Agency for the costs of responding to the audit.
