- Letter of Intent and Interim Agreement Between Endeavor Charter School and BC Construction Group ("LOI") was discussed at February 4, 2020 Meeting
- The Board agreed that the LOI would not be signed until BC Construction Group provided the Foundation Board a Preliminary Budget for the expansion project that fit within the School's financial advisor's estimate for potential funding of \$12,000,000
- On February 14, 2020, BC Construction Group provided a Preliminary Budget for the expansion at \$11,981,666
- Board discussed the budget and ramifications of signing the LOI
- Bill Kroll moved for approval to sign the LOI (attached to minutes). Jaclyn Parks seconded, and the motion passed unanimously.
