<u>Call to Order</u>: Bill Kroll

- Bill Kroll called the meeting to order at 7:11 p.m..

Approval of Agenda:

• Tracy DeMarco moved to approve the October 6, 2020 Agenda. Bill Kroll seconded, and the motion passed unanimously.

Approval of BC Construction Group, LLC, Contract

- Bill Kroll explained that the purpose of the meeting was for the Board and the Foundation Board to approve the final contract with BC Construction Group, LLC ("BCCG") for the construction of the new building, with official groundbreaking scheduled to take place in November. The terms of the contract are substantially similar to the draft BCCG shared in early 2020 when the Board and Foundation Board voted to move forward with preliminary steps toward the expansion. All members of both Boards had a chance to review the contract in advance of the meeting, and Bill and Michael Reinhardt, Foundation Board Chair, recently went over all of the terms with BCCG. No member of either Board had any remaining questions about the document.
- Bill Kroll moved to approve the Standard Design-Build Agreement and General Conditions Between Owner and Design-Builder (Cost of the Work Plus a Fee with a Gross Maximum Price of \$11,405,034) between Endeavor Charter School and the Endeavor Charter School Foundation, as Owner, and BC Construction Group, LLC, as Design-Builder, and to authorize the applicable officer to sign this contract plus any associated documents or amendments necessary to effectuate this Contract. Tracy DeMarco seconded, and the motion passed unanimously.
 - The Foundation Board simultaneously voted and unanimously approved the terms of the Contract.
