- Christi Whiteside reported that the School nurse, Sarah Ipock, has notified NCDHHS that ECS has reopened campus to all students on Plan A, per request from the Department of Instruction.
- All staff and most students are now back on campus for in-person learning.
- Jim Lundholm, Michael Reinhardt, and Nay Newell put up a shade structure for outdoor music classes near the parking lot.
