<u>Call to Order</u>: Dustin Embrey

- Dustin Embrey called the meeting to order at 6:01 p.m.

Approval of Internet Safety Policy:

Tracy DeMarco

- Tracy DeMarco explained that the School needs to adopt an Internet Safety Policy to meet the requirements of the e-Rate grant it receives from the federal government. The Governance Committee has been working with Christi Whiteside and Allison Hester to craft a policy that makes sense for our school. In the interim, however, the Governance Committee recommends the Board adopt the sample Internet Safety Policy provided by the North Carolina Department of Public Instruction. Christi and Allison believe the policy is implementable, and Governance believes it will bridge the gap between the e-Rate deadline to adopt the policy and the time needed to develop a policy that is catered to the ECS campus.
- Michael Gottlieb asked whether ECS has an existing Internet Safety Policy. Tracy DeMarco reported that the School currently has a Technology Policy. While there is some overlap between the Technology Policy and Internet Safety Policy, the Internet Safety Policy goes further to set standards for schools to monitor internet usage on its devices.
- Heather Flynt asked whether the new policy will be included in the student handbook. Tracy DeMarco responded that it will be published on the ECS website.
- Kristen Walsh asked whether ECS blocks access to certain websites. Tracy assured the Board that the School is already engaged in the process of blocking inappropriate websites so that students may not access them.
